E. DIRECTOR'S REPORT

The Institute of Chinese Studies is the only multidisciplinary institute on China and East Asian affairs in India, and one of its major priorities has been to promote the study of China all over India, support such study and research by providing specialised inputs and provide a networking platform for China scholars in the country. The other key action area has been the research, projects and publications of the Institute. In all these respects, the ICS made significant progress, reinforcing and diversifying its activities through 2014-15. The ICS also implemented its mandate to contribute to the public discourse on India-China relations through various media and social media platforms. In this context, I would like to specially mention the 'ICS-Delhi' Google group that now has more than a hundred members and a very active exchange of information and and opinions on all manner of developments concerning China and East Asia.

Organisationally, an important development in this year was the constitution of an Advisory Board, with Mr. Shivshankar Menon, the former National Security Advisor as the Chairman and a distinguished set of academic and corporate sector personalities as its members. These are Mrinal Miri (Former Director, Indian Institute of Advanced Studies, Shimla), Naina Lal Kidwai (Group Manager & Country Head, HSBC India), Rajendra Pawar (Chairman, NIIT), Romila Thapar (Emeritus Professor in History, Jawaharlal Nehru University) and Satish Reddy (Chairman, Dr. Reddy's Laboratories). The Board has had its first meeting and various plans to further enhance the profile and resources of the ICS are on the anvil.

The recognition of the ICS as a vital location for conducting research is reflected in the steady increase in the footfalls to our institute – from home and abroad. Our fellowship – both in formal and informal ways is on the rise. In 2014-15, we welcomed the association of Mr. V. Krishnappa (Said Business School, University of Oxford) and Dr. Sriram Natrajan (Independent Consultant on Economics, Development and Statistics) as Adjunct Fellows of the Institute. We receive a large number of applications for internships and for the past two years after now we have been taking in interns throughout the year. We are also extremely pleased to announce the completion of the *Encyclopaedia of India-China Cultural Contacts*, which had been funded by the Public Diplomacy Division of the Ministry of External Affairs, Government of India. This project had been the outcome of an agreement between the governments of the Republic of India and the People's Republic of China, involving expert groups from India and China who compiled this Encyclopaedia. This prestigious project was housed in the ICS and two of the five-member Indian team, viz, Prof Sabaree Mitra and Dr. Madhavi Thampi, are Honorary Fellows of the ICS. It was released in Beijing by the Vice-President of India, on the occasion of the sixtieth anniversary of the Bandung Conference, in June 2014.

RESEARCH PROGRAMMES AND PROJECTS

The research profile of the Institute continues to deepen and diversify. One of the core programmes of the ICS is the Border Studies Programme, which incorporates research work on a number of inter-related themes in an overarching, multidisciplinary framework. In 2014-15, the **Border Studies Programme**, released the result of an important multi-year study of infrastructure development in the border state of Arunachal Pradesh, titled, 'Territory, Tribes, Turbines: Local Community Perceptions and Responses to Infrastructure Development along the Sino-Indian Border in Arunachal Pradesh', in the form of an ICS Occasional Paper by Mirza Zulfiqur Rahman. There were also several other ICS publications on subjects ranging from Tibet to the BCIM Economic Corridor. The ICS also organized a workshop on border studies in Northeast India in Guwahati, Assam in March 2015 together with the Association for Borderlands Studies. ICS faculty participated in and presented papers at a number of important conferences — held in both China and India - on the theme of China's Belt and Road Initiative, focusing on its implications for India's border areas.

The ICS is the Indian liaison office for the Bangladesh–China–India–Myanmar (BCIM) Forum for Regional Cooperation. Partnered by the Centre for Policy Research (New Delhi), the BCIM Forum is a Track II sub-regional initiative launched in 1999 to explore the possibility of cooperation on trade, transportation, tourism, and people-to-people relations between China's South Western provinces and India's North East and Eastern regions, along with Bangladesh and Myanmar. The BCIM Forum has held 12 meetings to date, the latest being in Yangon in February 2014. Among the activities co-organized by ICS was the Kolkata to Kunming ('K2K') Car Rally of February/March 2013. Following the official visit of Chinese Premier Li Keqiang to India in May 2013, it was decided to set up a Joint Study Group (JSG) of the four BCIM countries to consider the possibility of creating a BCIM Economic Corridor from Kunming to Kolkata. Three research scholars of ICS, along with other specialists, are involved in the writing of the Joint Study Group Report, for which Stakeholders' Workshops were held in Kolkata (May 2014) and Guwahati (July 2014).

The second core programme is the Chinese Economy Research Programme (CERP), which seeks to undertake research and investigations into new opportunities for greater economic understanding and cooperation between India and China and which is currently being managed and shaped by Dr. Aravind Yelery who had joined us in May 2014. During this year, ICS was awarded an ICSSR sponsored project on WTO, Anti-dumping and China's Market Economy Status. In the course of this study, a Working Paper titled, Chinese Manufacturers' Response to 'Trade Remedies': From Dumping to Intelligent Trading, and two ICS policy papers titled "Applying the 'Going Out' Strategy: Chinese Provinces and Cities Engage India" and "China's 'Going out' Policy: Sub-national Economic Trajectories" by Aravind Yelery, have been produced. Under this programme, the ICS proposes to link up with other research institutes and organisations with similar interests, to build capacity among Indian researchers and practitioners and bring them within the ICS network. The CERP will be the ICS' platform for bringing together like-minded experts from India and China through a series of workshops and conclaves on doing business in China. We are also in the final stages of conceptualizing an immersion program for Indian management executives in China. A good beginning has been made with an MoU being signed with the Administrative Staff College of India, Hyderabad.

The third major research programme, which has seen the initiation of some significant projects this year, is the **India-China Comparative Studies Programme**. An ICSSR funded project titled *Transnational Actors and Commercialisation of Health Care: A China-India Comparative* was completed in March 2015. This study sought to identify the global actors and agencies in health care. It looked at their contributions, investments and influence on health policy and their contribution to changing the landscape of health services in India and China. Among the ongoing projects, an ICSSR funded **India-China Comparative Health Resource Centre** is located in the ICS. The specific objectives of this project are: to build a repository of all relevant issues on health and health care in China; to build networks and collaborations with scholars in universities and other institutes researching on health and health care systems in China; to conduct research on some selected domains on health systems in China and to publish occasional papers and to organize meetings/seminars.

Another comparative project titled *Indian and Chinese Ethnic Minority Policies: Comparing and Contrasting the Indo-Naga and the Sino-Tibetan Cases* seeks to undertake a comparison of the Indian and Chinese government's policies towards its ethnic minorities, taking the case of the Nagas and Tibetans respectively. The project concerns itself with the study of the various mechanisms, policies, programmes and arrangements, including the various institutions in the two countries at the national and local levels, to get a comparative sense about the rationale, representation and objectives of these bodies.

ARCHIVAL RESEARCH PROJECT

The ICS has sponsored a three-year research project with the aim of cataloguing documentary materials located within the National Archives of India (NAI) at New Delhi. These materials - contained in voluminous reports, data of various kinds, official notings and correspondence, as well as newspaper clippings, personal letters and photographs - pertain to the study of 19th and 20th century China and are of particular relevance to the study of India-China relations in the modern era. This has resulted in one catalogue on the materials related to China in the Special Collections section of the NAI, as well as another catalogue of the files from the Foreign & Political Department and External Affairs Department of the Government of India during the crucial years of World War II (1939-45). This is an initiative of immense long-term significance, which would hopefully encourage young Indian researchers to utilize these invaluable archival materials to produce original studies on China and India-China relations.

NATIONAL NETWORK OF INDIAN SCHOLARS OF CHINA

The All India Conference of China Studies (AICCS) is the flagship event of the ICS. The seventh in this series was held in collaboration with, and in the Banaras Hindu University, Varanasi and was a widely appreciated major event of 2014-15. Our call for papers received a record number of 117 applications from young scholars all over the country, out of which 37 were selected for making presentations. The keynote address titled 'Is the Concept of Secularism Relevant to China?: A Comparative Analysis' was delivered by Prof. Prasenjit Duara, Director, Asia Research Centre, National University of Singapore. Prof. Mark Frazier, New School, New York and Prof. Kjeld Erik Brodsgaard, Asia Research Centre, Copenhagen Business School, Denmark gave special lectures during the Conference. The Mira Sinha Bhattacharjea Award for the most promising young Indian scholar of Chinese Studies at the 7th AICCS went to Jigme Yeshe Lama, Research Scholar, Centre for East Asian Studies, JNU.

PUBLICATIONS

The ICS journal, *China Report* entered its 51st year of its publication in 2015. The journal continues to grow in strength and to attract new readership as reflected in its rising sales. To mark the 50th anniversary of China Report, ICS in collaboration with Sage Publications organised a special lecture on 16 December 2014, delivered by Prof. Anand A. Yang, Director, South Asia Centre and Co-Director, Global Asia Institute, Jackson School of International Studies, University of Washington. The title of the lecture was 'China Beyond the Seas: Indian Images of China in the late 19th and early 20th Century'.

In 2014-15, we produced fifteen ICS Analysis, three ICS Occasional Papers and six ICS Working Papers (drafts of works in progress that will eventually be revised and published) which are all available on our website.

CONFERENCES

2014-15 was also a very rich year as far as conferences and seminars were concerned. We derive much satisfaction that through these conferences, we increased the ambit of our collaborative partnerships. A two-day international conference from 12-13 September 2014 was organised in collaboration with the Japan Foundation on India and Japan: Roads to the Modern, in which several scholars from different countries participated. The conference sought to explore India-Japan cultural exchanges from a multi-disciplinary and comparative perspective, and more importantly, attempted to locate these exchanges within regional and global networks.

The efforts by our scholars working in the India-China Comparative Studies programme of the ICS to link up with researchers from China, bore fruit in the shape of two other significant international conferences. One was on the Education sector titled Higher Education in Transition: Perspectives from India and China, which was held in collaboration with ICSSR and the IIC on 27-28 February 2015. The other on the Health sector, on 10-12 March 2015 was titled Challenges to Health Service Systems in Transition: China and India and was held in collaboration with Centre of Social Medicine and Community Health, Jawaharlal Nehru University and ICSSR. Scholars from China participated in both the events generating a fascinating exchange of views and ideas.

We place on record our thanks to the India International Centre for their invaluable support and logistical facilitation of many of our important events.

One of our traditions, coterminous with the Institute, is the weekly Wednesday Seminar, which has been held uninterruptedly for the last three decades. The topics span an enormous range and attract students, experts, practitioners and laypersons alike. These seminars provide an opportunity for interested people to have access to informed discussions on various aspects of China and are ample evidence that the sections within India, which are interested in knowing and learning about China are widening and enlarging.

THE ICS-HYI FELLOWSHIP PROGRAMME

A veritable feather in our cap - and an initiative which distinguishes the ICS from other think tanks - is the support for training of the next generation of research scholars that we provide through the ICS-HYI [Harvard Yenching Institute] Joint Fellowship for Doctoral Research, which was instituted in January 2014. The HYI-ICS Fellowship seeks to develop high levels of Chinese language competence and academic proficiency amongst a carefully selected group of high-potential Indian students, so that over a period of time, China Studies in India can achieve depth and breadth of knowledge about China, which can also be systematically disseminated amongst a wider public. Our long-term goal is to make the HYI-ICS Fellowship a world-class scholarship initiative, along the lines of the Gates, Rhodes and similar programmes. As in the past year, this year as well, two scholars were selected. Bhim Subba registered in the Ph.D programme of the Department of East Asian Studies, University of Delhi, who is now pursuing advanced language training in the National Taiwan Normal University, Taipei and Severin Kuok registered in the PhD programme of the Centre for Chinese & South East Asian Studies, School of Language, Literature and Culture Studies, Jawaharlal Nehru University, who is now in Beijing University. Ms Veda Vaidyanathan, enrolled in the University of Mumbai, who had been selected in 2014, has also now moved to Beijing for her research.

GIRI DESHINGKAR MEMORIAL LECTURES

This series, which is co-hosted with the Centre for the Study of Developing Societies, Delhi, was instituted in memory of one of India's foremost scholars on Chinese security and strategy and also a founder member of the ICS. With his knowledge of Chinese history and culture, Giri Deshingkar's scholarship truly represents the multidisciplinary approach that we seek develop and promote. The 9th Giri Deshingkar Memorial lecture was held on 22nd December 2014. Prof. Shu-Mei Shih (Professor of Comparative Literature, Asian Languages and Cultures and Asian American Studies, UCLA and the Hong-yin and Suet-fong Chan Professor of Chinese University of Hong Kong) spoke on 'From World History to World Literature: China, the South and the Global 60s'.

COLLABORATIONS – ACADEMIC AND FINANCIAL

Our efforts to expand our international footprint made noteworthy strides, as 2014-15 witnessed the signing of several MoUs. These were with the Vietnamese Institute of Chinese Studies, Hanoi; the Administrative Staff College of India, Hyderabad and Indian Institute of Technology, Guwahati. ICS also signed an Agreement of Cooperation with the Centre of Social Medicine and Community Health, Jawaharlal Nehru University on 12 August 2014, which was marked by a special lecture by Prof. Manoranjan Mohanty on the 'Relevance of India-China Comparative Studies to Social Science and Development Policy'.

It bears repeating that India and China, ancient civilizations and the two of the largest and most populous neighbouring nations in Asia, need to promote and nurture a relationship of active and constructive cooperation, not only in their mutual interest but in the larger cause of the development and security of the planet. A major constraint in developing such a relationship is the serious deficiency in each country's knowledge of the other. It is therefore critically important to take decisive steps in strengthening the knowledge base on China and it is our conviction that the growth and expansion of the ICS is of vital national importance. Our initiatives, research and activities are capable of faster growth but our resources are far from adequate. Our efforts to build up our financial capabilities therefore, continue apace. The young and dynamic research faculty of the ICS, work in coordination with the senior honorary fellows, to take the ICS mission forward. Our most valued asset is our network of scholars, academics and researchers located in different universities and other institutions, from different disciplines and varied research interests. We feel privileged in playing a seminal role in strengthening these synergies which in turn reinforce our character, profile and output.

RESEARCH



The ongoing research programmes and projects are sound testimony to the multi-disciplinary character of the ICS, adding depth to our knowledge base and expanding the scope of our activities. Projects begun in 2013-14 have been smoothly progressing, even as some new ones have been taken on board. An ICSSR project was completed. Two short-term projects, granted by the Ministry of External Affairs are also underway. Another recipient of the ICSSR Senior Fellowships, who was affiliated with the ICS over the course of 2013-14, continued his association in 2014-15.

With its collaboration with the Indian Institute of Management, Indore and Administrative Staff College of India, Hyderabad, the CERP also initiated a programme for capacity-building among Indian researchers and practitioners and to connect them with the Institute's network of like-minded experts from both countries. This is being achieved through a series of workshops and conclaves on doing business in China and conceptualizing the immersion program for Indian executives in China.

PROJECTS COMPLETED



I. ENCYCLOPEDIA OF INDIA-CHINA CULTURAL CONTACTS

Project Convenor: Prof. Sabaree Mitra (JNU), Honorary Fellow, ICS Other Members: Dr. Madhavi Thampi, Honorary Fellow, ICS; Prof. Kamal Sheel, Banaras Hindu University and Prof Artatrana Nayak, Visva-Bharati, Santiniketan (Retired)

The Institute of Chinese Studies was the host institute for this project, funded and implemented by the Public Diplomacy Division of the Ministry of External Affairs, Government of India. This project was the outcome of an agreement between the governments of the Republic of India and the People's Republic of China, involving expert groups from India and China who are engaged in the compilation of this Encyclopedia. The project culminated in June 2015, with the release of the Encyclopedia by the Honourable Vice-President of India, during his visit to China.



II. TRANSNATIONAL ACTORS AND COMMERCIALISATION OF HEALTH CARE: A CHINA-INDIA COMPARATIVE (April 2013 – March 2015)

Project Directors: Madhurima Nundy, Associate Fellow, ICS and Prof. Rama V. Baru, Professor, Centre for Social Medicine and Community Health, Jawaharlal Nehru University and Adjunct Fellow, ICS.

Under the India-China Comparative Studies programme, an ICSSR funded project titled 'Transnational Actors and Commercialisation of Health Care: A China-India Comparative' was completed in March 2015. The study sought to identify the global actors and agencies in health care. It looked at their contributions, investments and influence on health policy and their contribution to changing the landscape of health services in India and China.

ONGOING PROJECTS

I. SHORT-TERM PROJECTS GRANTED BY EURASIA DIVISION, **MINISTRY OF EXTERNAL AFFAIRS**

The ICS was granted two short-term projects – India and SCO: From Observer Status to Membership, and India and China in Central Asia: Building a Cooperative Agenda by the Eurasia Division of the Ministry of External Affairs. In August 2014, field visits were undertaken by a team of researchers from the ICS, to Afghanistan, Tajikistan and Kazakhastan. A draft of the first project was submitted in September 2014.



II. MATERIALS RELATED TO MODERN CHINA IN THE NATIONAL ARCHIVES OF INDIA

Project Director: Dr. Madhavi Thampi, Associate Professor, Department of East Asian Studies, University of Delhi and Honorary Fellow, ICS & Nirmola Sharma, Research Associate, ICS

The National Archives of India (NAI) at New Delhi contains valuable documentary materials for the study of 19th and 20th century China and in particular for the study of India-China relations in the modern era. These include voluminous reports, data of various kinds, official notings and correspondence as well as newspaper clippings, personal letters and photographs. Some of these materials cannot be found at any other location. Despite the obvious importance of these materials to the study of China and of India-China relations, they have not been sufficiently utilized by Indian and foreign scholars. ICS sponsored a three-year project with the aim of cataloguing some of these valuable materials. This has resulted in one catalogue on the materials related to China in the Special Collections section of the NAI, as well as another catalogue of the files from the Foreign & Political Department and External Affairs Department of the Government of India during the crucial years of World War II (1939-45). To make it easier for researchers to navigate through these collections, the catalogues include among other things, a topical listing of contents, a comprehensive index and brief descriptions of the contents of each file. It is hoped that this would encourage young Indian researchers to utilize these invaluable archival materials to produce original studies on China and India-China relations.

III. 2016, CHINA'S MARKET ECONOMY ME STATUS AND ITS IMPLICATIONS FOR INDIAN MICRO, SMALL AND MEDIUM ENTERPRISES: A STUDY OF INSTITUTIONAL RESPONSES AND MICRO ECONOMIC TRANSITIONS IN INDIA

Project Director: Aravind Yelery, Visiting Associate Fellow, ICS

The project sets out to analyse contemporary debates within both China and India, on China's Market Economy transition and effects on deciding 'normal value', along with investigating China's Non-Market Economy (NME) status and its implications for trade remedy disputes from 2001. The research also attempts to understand the legality associated with concepts such as NME and ME by investigating the role of state agencies, which affect industries in China.

IV. INDIAN AND CHINESE ETHNIC MINORITY POLICIES: COMPARING AND CONTRASTING THE INDO-NAGA AND THE SINO-TIBETAN CASES

Project Director: Tshering Chonzom Bhutia, Visiting Associate Fellow, ICS

The project seeks to undertake a comparison of the Indian and Chinese government's policies towards its ethnic minorities, taking the case of the Nagas and Tibetans respectively. Both New Delhi and Beijing's approach has been to put in place mechanisms — including autonomous arrangements, preferential policies and developmental programmes — to contend with at least the socio-economic roots of ethnic minority discontent and sub-national identity assertions. The study concerns itself with the study of these various mechanisms, policies, programmes and arrangements, including the various institutions in the two countries at the national and local levels to get a comparative sense about the rationale, representation and objectives of these bodies.




V. COMPARATIVE HEALTH RESOURCE CENTRE PROJECT

(ICSSR Responsive Research Project)

Project Director: Madhurima Nundy, Associate Fellow, ICS

The specific objectives for this project funded by the ICSSR are: to build a repository of all relevant issues on health and health care in China; to build networks and collaborations with scholars in universities and other institutes researching on health and health care systems in China; to conduct research on some selected domains in health systems in China; to publish occasional papers and to organize meetings/seminars.



VI. SINO – INDIAN BOUNDARY ISSUE – ICS DOCUMENTATION PROJECT

Project Director: M.V. Rappai, Honorary Fellow, ICS

This project is intended to make an extensive database of all issues involving the India-China boundary and eventually make the Institute of Chinese Studies a key repository of data on all aspects of India-China relations in the long term.

The first phase is from 1914 to 1916 (collection of part of archival data and indexing of relevant publications has already been completed).

The second phase would look at the historical evolution of this issue from 1945 to 1954, coinciding with the period when the two nations emerged as modern independent states and the third phase would cover the period 1955 to 1964, encompassing the decline in relationship from the bonhomie of 1954-55 up to the outbreak of the border conflict in 1962 and the end of the Nehruvian period.

Proposed Database: Compilation of a bibliography (as also copies) of all relevant materials, including books, articles, available archival material; all relevant doctoral theses produced/published in major Indian Universities; material/copies from relevant state/district archives; and possible tie-ups with the archives of some leading newspapers of India (a basic survey has already done). The plan also includes – over the longer period – collecting all relevant material available in Chinese language, including in the archives of P R China, Taiwan and the UK.

VII. STATE RESPONSES TO SOCIAL WELFARE IN CHINA AND INDIA: A COMPARATIVE STUDY OF WORKERS IN SMALL AND MEDIUM ENTERPRISES

(ICSSR Responsive Research Project)

Project Director: P.K. Anand, Research Assistant, ICS

The project seeks to study the role of the state (at the national and sub-national levels) in both countries on its relations vis-à-vis the labour dynamics and social security-welfare system. Against the backdrop of market reforms, the changing priorities of the State since the late 1980s and the ramifications of the departure from the state-oriented system, the research examines the institutional responses of the state in meeting the challenges that subsequently emerged. The study focusses on policy-making as well as implementation practices with regard to labour relations and the social security system in Small and Medium Enterprises in both countries, emphasizing on the case of workers in Leather-based enterprises.

VIII. COOPERATION A KEY FOR MARITIME SECURITY- EXAMINING A CASE FOR SINO-INDIAN COOPERATION FOR MARITIME SECURITY IN INDIAN OCEAN - ICS PROJECT

Project Director: Virendra Sahai Verma, Honorary Fellow, ICS

The project seeks to analyze the feasibility and practicality of Sino-Indian cooperation in Indian Ocean in the light of existing politico-strategic relations between the two Asian powers. It would attempt to determine the scope and geographic extent of maritime cooperation. An ICS Occasional Paper, which would be primarily intended as a policy brief to the Government of India, would be the outcome.




