EXECUTIVE SUMMARY

- The seminar addressed the evolving geopolitical role of middle powers in a world increasingly characterised by rivalry between major powers, particularly the US and China. Prof. Rafiq Dossani traced how middle powers have historically shaped global stability and how their role is transforming contemporary geopolitics.
- The Chair, Prof. Sandip Mishra, underscored the importance of understanding the Indo-Pacific as a contested space, especially with regard to China's assertiveness and the ambivalent stance of US allies on contentious issues such as Taiwan.
- Prof. Dossani categorised states using Keohane's taxonomy: system-determining (e.g., US), system-influencing (e.g., UK), system-affecting (e.g., Kazakhstan), and system-ineffectual (small states), while also proposing "system-disrupting" powers like India that can unsettle global systems without redefining them.
- The speaker highlighted how middle powers such as India, Turkey, and Brazil are
 increasingly asserting strategic autonomy, pursuing regional leadership, and acting
 outside traditional alliance structures. He discussed the nature of power as being
 shaped by autonomy, material resources, and ideological conviction, which, when
 combined with diplomatic and military tools, create real influence. The speaker
 applied an Inputs–Processes–Outputs–Outcomes model to explain how power is
 converted into impact.
- Prof. Dossani maintained that China seeks not global hegemony but the prevention of
 US dominance. The Belt and Road Initiative (BRI) exemplifies China's approach to
 soft power projection and economic diplomacy.

 The session concluded with a discussion on ASEAN's role as a potential middle power and the relevance of track 1.5 diplomacy as a means to mitigate tensions and avoid escalation between the US and China. The speaker called for middle powers to adopt a more proactive role in fostering stability and multilateralism, especially as great powers retreat into strategic competition.
